

# **Jessie F. Richardson Foundation Ladd Award recognizes Housecall Providers founder Dr. Benneth Husted**

PORTLAND, OR—The Jessie F. Richardson Foundation (JFR) has selected Dr. Benneth Husted as the 2011 recipient of its Ladd Award for Home and Community Based Care. Dr. Husted is founder and medical director of Housecall Providers, a Portland, OR-based nonprofit that provides primary medical care and hospice services for homebound adult patients.

In selecting her for the award, the Foundation said: “Since 1995, Dr. Husted has worked tirelessly to help older adults, particularly those difficult to serve in traditional medical networks. Housecall Providers

has helped countless older adults to remain in less restrictive environments and receive the medical care they need. Housecall Providers is unique among health care providers, known for sending physicians to the settings where their patients live. For many, particularly those with chronic physical and mental conditions, this makes the difference in their ability to remain in more independent settings.

“Dr. Husted’s vision and commitment to increase access to medical care for this type of patient has resulted in wide recognition and admiration of Housecall Providers.”

Jessie F. Richardson was the mother of Keren Brown Wilson, who founded the JFR Foundation and co-founded Concepts in Community Living (CCL) with her spouse, Michael DeShane. CCL manages The Taft Home, a residential community serving low income older and disabled adults in downtown Portland.

Dr. Husted holds a D.O. degree from Michigan State University College of Osteopathic Medicine and is board certified in family practice by the American College of Osteopathic Family Physicians. She began making medical house calls as a sole practitioner in 1992, and incorporated Housecall Providers in 1995. Over the years, she has cared for numerous residents of The Taft Home. Currently, family nurse practitioner J.C. Provost, a lead clinician for Housecall Providers, serves as the “house doc” for The Taft.

Dr. Husted said she was honored to receive the award, particularly coming from an organization she has long admired.
